BACKGROUND:

Section 15.2-2230 of the *Code of Virginia* stipulates that at least once every five years, the comprehensive plan shall be reviewed by the local planning commission to determine whether it is advisable to amend the plan. The five year deadline is 2025 for review of Isle of Wight County's comprehensive plan, *Envisioning the Isle*, adopted in 2020.

Envisioning the Isle Comprehensive Plan Five Year Review Stakeholder Workgroup Draft Scope of Work Rev 3/19/24

Section 15.2-2230 of the *Code of Virginia* stipulates that at least once every five years, the comprehensive plan shall be reviewed by the local planning commission to determine whether it is advisable to amend the plan. The five year deadline is 2025 for review of Isle of Wight County's comprehensive plan, *Envisioning the Isle*, adopted in 2020.

In order to facilitate this review, the Planning Commission will lead the formation of the Comprehensive Plan Review Stakeholder Workgroup consisting of its members and other stakeholder representatives, such as private citizens, appointed officials, and elected officials. This group will assist in the review of the current Comprehensive Plan and suggest revisions as needed to reflect current conditions and updated information. County staff will provide technical support to the workgroup.

Suggested members of the workgroup include representatives from the Energy task force, Commission on Aging, Town of Windsor Planning Commission, Town of Smithfield Planning Commission, Chamber of Commerce, Carrollton Citizens Association, the South and Central Isle of Wight Association, and staff from various departments for technical support as appropriate.

Following the review of background material and the Comprehensive Plan, the draft revisions will be presented to the community at large as well as the Planning Commission and the Board of Supervisors for their review and feedback. The final draft revised Plan will be subject to a public hearing for final comment at both the Planning Commission and Board of Supervisors prior to adoption.

The following is a proposed scope of work for the workgroup:

- 1. Provide feedback during the development of the proposed Growth Rate Impact Scenario Study to be prepared by an outside consultant and incorporate the study's findings into proposed revisions to the Comprehensive Plan as necessary.
- 2. Provide feedback during the development of the proposed Housing Study to be prepared by an outside consultant and incorporate the study's findings into proposed revisions to the Comprehensive Plan as necessary.
- 3. Form subcommittees from the larger stakeholder workgroup to review each of the Plan's chapters. Each subcommittee will be responsible for presenting proposed revisions to their chapters at the end of the review process to the larger workgroup for incorporation into the draft revised Plan document.
- 4. Workgroup members will also provide feedback on the community input survey, public meeting format, and draft plan documents.

The initial meeting of the workgroup is tentatively scheduled for July 9, 2024. It is suggested that the stakeholder subcommittee groups meet the second Tuesday of the month during the review process, because this is the day normally held for Planning Commission worksessions.

Staff recommends that the Planning Commission provide recommended stakeholder members to staff by their regular April 23, 2024, meeting date.
